Q.7 Mr. Sunil Anand had been appointed as an accountant in the NGO 'Sahara' located in Gandhinagar. Recently there have been suspicions about some financial irregularities in the organization. Last month it was discovered that there is a deficit of Rs. two lakhs in the account of the NGO.

An Inquiry Committee has been constituted to look into the matter. Mr. Akshar Pokhrial has been appointed as chairperson of the Inquiry Committee constituted in-house. In order to establish the facts, Mr. Akshar inquired about the bank details of Mr. S.Anand without his permission or knowledge. The aggrieved party therefore instituted a plaint in the District Court.

Write a plaint on behalf of the complainant.

- Q.8 Write a written statement in response to the above mentioned Plaint. The defendant states that as a Chairperson of an Official Inquiry Committee he has been authorized by the NGO to collect facts. In the interest of Justice and Equity he should have access to all relevant documents. He also states that his intentions are bona fide and he means no harm. Present convincing arguments in favour of the defendant.
- Q.9 Professor Vasu of IIT Gandhinagar, has invented a multifunctional robot called 'Shivo' for harvesting and other related agricultural activities.

He has successfully obtained a patent from Ahmedabad Registry on 5 January 2016 numbered KS/09/2013/123. He has now been approached by Mahyco a manufacturing unit, for utilizing his patent named 'Shivo'.

They have offered him a sum of Rs. 1.5 crores and wish to sign a formal agreement. Write an assignment deed accordingly.

- Q.10 Mr. Mahindra had given a notice to Mr. Vijay Kallya regarding Dishonour of cheque of Rs. twenty five lakhs only, on 10th February 2016. Mr. Vijay Kallya had not given any response regarding that within the time prescribed in the notice. Mr. Mahindra residing at Bengaluru had deposited the said cheque in his bank at Bengaluru. Now, Mr. Mahindra wants to file a complaint in the court of Metropolitan Magistrate, Bengaluru. Draft the complaint accordingly.
- Q.11 Mr. Shyam a resident of Chennai had given a cheque dated 3 February 2016 for Rs.75,000/- to Mr. Ram a resident of Vishakhapatnam in order to return a loan that he had taken three years ago from Mr. Ram. When Mr. Ram presented the cheque before his banker, situated in Trivandrum, it was returned to him by the banker with the remark "insufficiency of funds". Now Mr. Ram wants to give a notice for dishonour of cheque to Mr. Shyam. Draft a **notice** on behalf of Mr. Ram.
- Q.12 Mr. Sudhir Shah is the owner of a trademark "Sundara" related to diamond jewellery. He got this trademark registered from Ahmedabad Registry on 10th March 2012 with registration number 90631. He wants to assign this trademark to Mr. Rajat Jain. The consideration amount agreed upon by them is Rs. 5 crores. Draft an assignment deed accordingly.
