Mrs P, a 68-year-old married housewife, lives with her husband in a farm. She was presented to the Emergency Department at the Monash Medical Centre with diarrhea and moderate dehydration following bowel resection two weeks earlier to remove carcinoid tumours. This follows a two-and-a-half year history of depression and weight loss, which has seen Mrs P become increasingly housebound and more dependent on her husband, who also suffers from depression, for care. Her current critical state follows closely on the suicide of her youngest daughter (aged 39 years) in March this year. She was often moody and sad without any reason. Sometimes she became irritable and withdrew from social situations. At that time she lost her interest in social life and was thinking about committing suicide.
