We live in an age of great hurry and great speed. Men have lost their inward resources. They merely reflect opinions like a set of mirrors. When they get a little leisure, they turn to material diversions from outside rather than to inward resources. This internal vacuum is responsible for mental and nervous troubles. The cure for this is not so much treatment by medicine and surgery but a recovery of faith in the ultimate goodness, truth and the decency of things. If we are able to recover that faith, if we are able to live in this world with our consciousness centered in the intimacy of the spirit, many of the problems to which we are subject today may be overcome. Our people were regarded as aspiring after metaphysical insight, but we seem to forget that it never occurred to them to equate eternal life with either the surrender of the mind or the sacrifice of the body. When an Upanishad scholar was asked to define what is meant by spiritual life. He gave the answer that it consists of the satisfaction of the mind, the abundance of tranquility of the spirit.
