
The conference went beyond theoretical discourse, offering practical workshops that equip participants with the skills needed to navigate the legal intricacies of the energy sector.

## Championing Legal Excellence: The 15th GNLU International Moot Court Competition



GNLU hosted the 15th edition of its prestigious GNLU International Moot Court Competition (GIMC) from 15 to 18 February.

This year's moot problem ignited critical discussions at the intersection of indigenous rights, environmental sustainability, and international trade, focusing on the global implications of lithium mining.

The competition attracted 35 teams, including several international participants, showcasing the event's growing global reputation.

In a closely contested final, National Law University, Delhi, emerged as the champion, while Dr Ram Manohar Lohiya National Law University, Lucknow, was the runner-up. Damodaram Sanjivayya National Law University, Visakhapatnam, earned accolades for Best Written Submissions. Paavni Dua and Manya were recognised as the Best Orators in the preliminary and final rounds, respectively, and Mohammed Rayyan was awarded Best Researcher.

Since its inception in 2009, GIMC has witnessed exponential growth and is now recognised by prestigious organisations such as the American Society of International Law (ASIL), the International Law Students Association (ILSA), and the Asian Society of International Law (Asian SIL).



## **Understanding North East India: An Exposition**

GNLU, in collaboration with GNLU alumni-run Rudram Dynamics and IIT-Madras Pravartak Technologies Foundation, organised a ground-breaking course on "Understanding North East India: An Exposition" to develop a framework for integration and position the region in India's national security discourse.

The course was divided into two levels: Level I covered the region's history, society, economy, and security challenges, while Level II focused on issue-oriented themes such as Geo-locating North East in the Indian subcontinent, the India-Naga Conflict, the India-China Boundary issue in the Eastern Sector, Manipur-Myanmar and Small Wars, and Armed Forces (SP) Act. 

#### Aarsh Soni at Gujarat Youth Parliament


